

OFFICIAL RULES

2026 Jayco Drawing

The following promotion is intended for attendees of the **2026 Hershey America's Largest RV Show** at the **Giant Center, 550 W. Hersheypark Drive, Hershey, PA 17033**, from **September 16, 2026 to September 20, 2026** (the "Event"), located in the 50 United States and D.C. only and will be construed and evaluated according to United States laws. Do not participate in the promotion if you are not an attendee of the Event who is a legal resident of the 50 United States or D.C., 18 years or older.
